Definition of Parishioner

In order to qualify for parish rates, you must be a contributing parishioner. A family who uses their church envelopes at least once a month for 12 months plus the Christmas and Easter envelopes is considered a parishioner.

Tuition Policy

All families are obligated to meet tuition payments as required by the contract of Our Lady of Humility. All families are required to be on a ten month FACTS contract (August to May), unless paying in full or selecting half and half. The FACTS payments may be reduced by making a payment directly to the Business Office.

Parent Participation

The Tuition Contract will include the OLH School Parent Participation contract to be administered by the School Board. All families are required to select a Parent Participation position.

Your participation activity will be available in August on Fee Day. If you choose not to participate, you may pay \$610.00. Parent Participation information is available online at the school website (www.olhschool.org) Your family's choice must be made by June 10, 2011 or it will be assigned.

Annual Walk-A-Thon

The tuition contract also includes participation in the annual fall Walk-A-Thon by securing and collecting pledges of at least \$60 per family. More information will be given in the beginning of the school year.

School Fees

All school fees must be paid on or before June 10th. These include Registration, Book and Technology fees. Please return check for all students' fees with this form and no later than June 10.
